The Several Persons WHOSE NAMES ARE HERETO SUBSCRIBED AND WHOSE DESCRIPTIONS ARE CONTAINED HEREIN, AND OF WHOM..... ARE ENGAGED AS **SAILORS**, HEREBY AGREE TO SERVE ON BOARD THE SAID SHIP, IN THE SEVERAL CAPACITIES EXPRESSED AGAINST THEIR RESPECTIVE NAMES ON A VOYAGE FROM:

FROM A TERM NOT EXCEEDING:

AND THE CREW AGREE TO CONDUCT THEMSELVES IN AN ORDERLY, FAITHFUL, HONEST, AND SOBER MANNER AND TO BE AT ALL TIMES DILIGENT IN THEIR RESPECTIVE DUTIES AND TO BE OBEDIENT TO THE LAWFUL COMMANDS OF THE SAID **MASTER**, OR OF ANY PERSON WHO SHALL LAWFULLY SUCCEED HIM, AND OF THEIR SUPERIOR OFFICERS, IN EVERYTHING RELATING TO THE SAID SHIP AND THE STORES AND THE CARGO THEREOF WHETHER ONBOARD, IN BOATS OR ON SHORE; IN CONSIDERATION OF WHICH SERVICES TO BE DULY PERFORMED, THE MASTER HEREBY AGREES TO PAY THE SAID CREW AS WAGES THE SUM AGAINST THEIR NAMES RESPECTIVELY EXPRESSED, AND TO SUPPLY THEM WITH THE PROVISIONS ACCORDING TO THE SCALE INDICATED HEREIN.

IT IS AGREED THAT THE FOLLOWING ACTIONS SHALL BE DEEMED PUNISHABLE OFFENCES WHILE UNDER THIS AGREEMENT:

1. STRIKING OR ASSAULTING ANY PERSON ON BOARD.
2. BRINGING OR HAVING ONBOARD INTOXICATING LIQUORS.
3. DRUNKENNESS OR BEING UNDER THE INFLUENCE ON DUTY.
4. TAKING ONBOARD AND POSSESSION OF ANY FIREARM, SLUNG SHOT, SWORD STICK, DAGGER, OR ANY OFFENSIVE WEAPON WITHOUT THE CONCURRENCE OF THE MASTER,
5. INSOLENT AND CONTEMPTUOUS BEHAVIOR TO THE MASTER OR ANY OFFICER,
6. ABSENCE WITHOUT LEAVE

AND IT IS HEREBY AGREED THAT ANY WILLFUL OR NEGLIGENT DESTRUCTION OF ANY PART OF THE SHIP'S CARGO OR STORES SHALL BE MADE GOOD TO THE OWNER OUT OF THE WAGES OF THE PERSON GUILTY OF THE SAME .
